Handover of the wool felt business to Wiler Filz AG

Today I am writing to inform you of a significant and forward-looking change to our business operations. After many successful years as the owner of Fissco AG, the time has come for me to pass on the baton;

as of 1 January 2027, we will be withdrawing from the wool felt production and manufacturing sector and transferring the business to Wiler Filz AG in Münchwilen (CH).

Why Wiler Filz AG?

With my retirement in mind, it was important to me to ensure quality and reliability in the long term. In Wiler Filz AG, we have found a partner that shares our values and philosophy. Patrick Andri (Owner & Managing Director) and I have known each other for many years and have played an active role in shaping the Swiss felt market.
